Applications are invited for selection of a suitable candidate on deputation/contract for a fixed tenure of 5 years or date of retirement or as decided by the Govt., whichever is earlier, for the post of Director in North Eastern Institute of Folk Medicine (NEIFM), Pasighat (Arunachal Pradesh), an autonomous organization under the administrative control of the Ministry of AYUSH, Government of India in the pay band 4 of Rs. 37,400-67,000/- with Grade Pay Rs.8700 +NPA and other usual allowances admissible as per Central Govt. Rules.



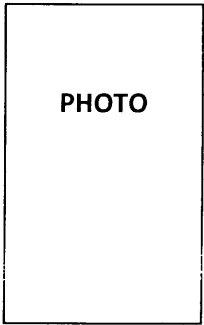
