### Condition for appearing in the interview:-

Eligible candidates will have to produce the original Certificates and testimonials (including mark lists) in support of your educational qualification, experience, age etc. at the time of interview. They should also produce original certificate in support of claim for being a SC/ST/OBC, if applicable.

In case the eligible candidates are presently employed in a Government/Semi-Government/Autonomous Organization/Public Sector Undertaking and their application has not been forwarded through proper channel, they are requested to produce a 'No Objection Certificate' from their employer at the time of interview, failing which they will not be allowed to appear for interview.

**No TA/DA will be given for appearing in the Interview.** They should make their own arrangement for fooding and lodging while appearing for interview.

Eligible candidates are required to report to the **office of the Director, All India Institute of Ayurveda, Mathura Road, Gautam Puri, Sarita Vihar, Delhi - 110076 by 0900 Hrs.** with all the original documents so that the formalities of verification of certificates etc. can be completed before commencement of the interview.

**Candidates are required to come prepared with a power point presentation of not more than 10 minutes duration in the respective field of specialization at the time of interview.**

All other conditions not specified herein shall be governed as per existing order of the DoPT, Government of India.
